Birmingham, AL (November 13, 2015) – Daniel Corporation announced today the completion of the most recent phase of the Lane Parke Development with the opening of the Grand Bohemian Hotel, a 100 room luxury hotel located along Lane Parke Road in Mountain Brook, AL.

Daniel Corporation, in partnership with Evson, Inc., commenced development of the Lane Parke master planned development in 2013 with the completion of certain infrastructure improvements followed by the construction of the Lane Parke Apartments which were completed in 2014.
